If your trip includes other countries, please contact the relevant embassy to confirm visa requirements.
- We strongly recommend that you take out travel insurance at the time of booking to ensure that you are covered for cancellation, should this be necessary, prior to your departure.
- No vaccinations are currently required for visiting Japan. However, we recommend that you confirm your suitability to travel to all countries included in your trip with your GP.

- From 21st November 2007 new immigration procedures came into effect. On arrival in Japan, foreign nationals will now have fingerprints and a facial photograph taken by Japanese Immigration officials. Entry into Japan will be refused to anyone who refuses to submit to these procedures.

- The contents of any sightseeing tours or cultural activities are subject to change due to local circumstances and conditions.
